Notes: This website utilizes various technologies that are meant to make it as accessible as possible at all times. We utilize an accessibility interface that allows persons with specific disabilities to adjust the website's UI (user interface) and design it to their personal needs. This interface replaces the controversial approach to accessibility in which all users are presented with the same diminished interface or design. Additionally, the website utilizes an AI-based application that runs in the background and optimizes its accessibility level constantly. This application remediates the website's HTML issues, adapts the functionality and behavior of the website for screen-readers used by the blind users, and keyboard functions used by individuals with motor impairments.

Evaluation Methods Used: Product knowledge. User experience feedback. Testing with AccessiBe's Assistive Technologies. Browsers: Google Chrome, Firefox, Safari Devices: Mobile Devices, Mac, Tablets, Windows Devices
